## **TERMS :**

1. \$ 500 deposit is required upon signing of the contract and the balance of \$ 500 is due by April 1st, 2011. The total amount of \$ 1000 must be spent during the 2011 season
2. For everyone's benefit, the company will make sure that its players respect the maximum playing time allowed oh 4 hours and 30 minutes.
3. All reservations will be invoiced even if the client does not show up, unless a telephone cancellation is made at least 24 hours in advance.
4. An invoice will be sent at the end of each month and is payable in full within 30 days from receipt of invoice. Any unpaid balance will result in the cancellation of the discount by Les Quatre Domaines and will carry a 2 % monthly interest surcharge.
5. Only one method of payment is accepted to pay the statement of account. A credit card can be used to pay the statement automatically each month
6. Proper golf attire is required. Soft spikes are mandatory and jeans are not allowed. The dress code applies to all golfers and visitors..
7. This agreement is valid for the 2011 season only.
8. Non-compliance of any clause may lead to the cancellation of the agreement.
9. A credit inquiry may be executed to validate the company's credit standing.
10. It is essential to keep all your transaction receipts in order to validate your monthly statement of account.
